



## Terms and Conditions for 2024 NC Plein Air Workshops

### Enrollment and payment schedule:

To confirm your enrollment, you must:

1. Submit a profile form. [Click here to access this form.](#)
2. Submit a deposit of \$100.00 or full balance of workshop tuition through the payment portal, you do not need a PayPal account to use this method with a debit or credit card. The enrollment form will automatically direct you to the payment method. [NCPleinAir.org](http://NCPleinAir.org)

A deposit of \$100.00 due at time of enrollment will reserve your space in the workshop. The total balance is due April 10, you will receive an invoice for the balance.

*There is a minimum enrollment of six students per workshop. You will be notified by your workshop coordinator when the workshop is "made". Please keep this in mind when you make any travel arrangements.*

**Covid:** Workshops cancelled due to a published mandate of the State of North Carolina, or cancellations due to the illness of the instructor will result in full refunds. Personal cancellations for covid related reasons will follow the guidelines of the general cancellation policies.

Prior notice of mobility issues should be discussed with the organization before enrollment. We will make every effort to accommodate your needs.

**Cancellation policy:** In the event of cancellation, payment will be refunded, less the following:

- Registration fee \$40.00 per person.
- More than 30 days prior to workshop, full refund less registration fee will be honored.
- Within 30 days of arrival, no refund unless there is a waiting list and your place can be filled, the registration fee of \$40.00 is non-refundable

**Insurance:** We do not provide travel or cancellation insurance of any kind. If you wish to purchase it on your own, we will supply any documentation helpful.

**Responsibility:** NC Plein Air Art Festival, Plein Air New Bern Inc, booking agents, trip escorts, trip organizers, sponsors, event volunteers act only as agents for the participants and assume no liability for any injury, damage, loss, accident, delay or irregularity which may be occasioned either by reason of

defect in any vehicle or through acts of default of any company or persons engaged in conveying the passengers or in carrying out the arrangements of the trip. We can accept no responsibility for losses or additional expense due to delay or changes in train or other services, sickness, weather, strikes war, quarantine, uncontrollable events or other causes such as not meeting the trip minimum. All such losses will have to be borne by the passengers as trip rates provide arrangements only for the times stated. Baggage is at owner's risk. The trip organizer accepts no responsibility for securing, handling, or possession of passports or travel documents; nor for the accuracy of information given regarding such documents. It is the responsibility of the passenger to make sure that he/she is in possession of the proper travel documents and is in compliance with the current carrier and government regulations.
